Performance Agreement

This Agreement is between **[The Client]** ("Event Booker") and **James Taylor** ("Performer") for a live musical performance at the agreed venue ("Venue") on the agreed date and time ("Event").

1. Event Details

The Performer will provide a musical performance at the agreed Venue, date, and time. Musical content is at the Performer's discretion, including any requests.

2. Fees & Payment

The total fee ("Fee") is as invoiced.

- A **50% non-refundable deposit** is due within 7 days of invoice to secure the booking.
- The **remaining balance is due no later than 6 months before the Event.**
- If the deposit is not received, no contract is formed and the date is not reserved.

3. Cancellation

- If the balance is not paid by 6 months prior, the Performer may cancel with no liability.
- If the Event Booker cancels more than 6 months before the Event, the deposit is forfeited.
- If the Event Booker cancels within 6 months, the full Fee remains payable.
- If the Performer cancels (excluding force majeure), any payments made will be refunded in full.

4. Force Majeure

If the Event cannot proceed due to circumstances beyond reasonable control (including illness), the Fee is non-refundable. The parties may agree to reschedule under the same terms (new agreement required). If no suitable date is agreed, the Fee is forfeited.

5. Venue & Logistics

The Event Booker will ensure:

- Suitable, safe performance space protected from weather
- Adequate security and insurance where appropriate
- Convenient parking for the Performer (2 hours before until 1 hour after the Event)
- Where the performance takes place during a wedding breakfast or similar meal service, a **supplier meal** will be provided for the Performer

6. Liability

The Event Booker is responsible for maintaining appropriate public liability and venue insurance. The Performer is not liable for circumstances outside their control.

7. Disputes

Any disputes will be resolved via arbitration (www.judge.me). Each party bears its own costs unless otherwise awarded.

8. General

- This Agreement is governed by the laws of England.
- If any provision is invalid, the remainder remains in force.
- **Payment of the deposit or full Fee constitutes acceptance of these terms and forms a binding agreement between the parties.**
